

Brexit Survey Q1 2017

Following the publication of the Government's Brexit White Paper, which set out its key negotiating objectives, we asked businesses in the region about their attitudes and interests on issues relating to Brexit and the general business environment. The survey provides a snapshot of business sentiment and activity in the immediate run-up to the triggering of **Article 50**.

of businesses are not currently taking any specific measures in preparation for Brexit.

31%

of exporting businesses have no experience of using customs documentation to trade with other countries.

Uncertainty levels



of respondents say there is 'strong' or 'moderate' uncertainty around rules for future trading with EU countries.



say they are uncertain about the future impact on the supply chain.



say they are uncertain about the future status of EU regulations in the UK.

51% of respondents believe leaving the single market will be negative for their business, while 19% think the impact on their business will be positive.



More admin for exporters?




of exporting firms think Brexit will have negative implications for customs paperwork ϑ procedures (10% think the impact will be positive).
